Board Resolution to Establish Non-Business Days for Public Information Act

WHEREAS, Center Independent School District is a governmental entity obligated to comply with the Texas Public Information Act (hereinafter "the Act"); and

WHEREAS, the 88th Texas Legislature (2023) authorized the passage of HB 3033, which revised the Act by adding section 552.0031 to the Government Code, defining "business days" for purposes of the Act; and

WHEREAS, Section 552.0031 defines "business day" to generally to mean any day other than a Saturday or Sunday, a national holiday, or a state holiday or the Monday or Friday on which a state or federal holiday that falls on a Saturday or Sunday is observed; and

WHEREAS, Section 552.0031 establishes that a school district board of trustees may designate up to ten additional days per calendar year as non-business days; and

WHEREAS, the Board recognizes that the District's academic calendar includes dates of closure that do not meet the statutory definition of business days; and

WHEREAS, the Board recognizes that designating additional non-business days will allow school staff to work in better alignment with the District's academic calendar when responding to information requests.

Now therefore it be resolved by the Board that:

- The Center ISD Board of Trustees determines that the District will designate the specific dates listed in the attached **Exhibit A** as "non-business days" for purposes of the Public Information Act in 2026; and
- 2. The Board hereby authorizes the Superintendent to undertake additional measures as necessary to implement this designation.
